Although small local societies should restrict themselves largely to short-term loans, they have often made large loans for the repayment of old long-term debts. The need to think carefully of repayment plans for individual members has not been adequately realized, nor has there been sufficient additional repayment of old debts in more favourable years. Another common failing has been abuse by committee members of their positions; they secured large loans which they were unable to repay and so became unable to control other defaulters.30 Credit is indeed a two-edged sword that may destroy the unskilful wielder. A fourth difficulty aggravating the third has been the great instability of farm product prices, particularly in poorer countries dependent on export markets for comparatively few major products.
